BLOCK PARTY CONDITIONS

1. Fill in the top portion of the petition.
2. Block Party organizer/sponsor must sign the petition in space #1, including **name, address, and phone number**.
3. All houses in the area must be canvassed by the applicant. If the street in front of a resident's house will be blocked off, the resident's signature is required. **Signatures will be verified.**
4. A majority of the residents (**75% or more**) must agree to have the street blocked off.
5. **A map must be drawn on the reverse side of the petition or separate page, indicating the exact location/address of where the street will be blocked.** Blocking off the street is your responsibility. Vehicles may **NOT** be used. Only those barricades provided by the Village of Glendale Heights may be used to block the street. Block Party organizer / sponsor must sign for responsibility of the barricades on the Friday preceding the Block Party. Call Stan Vimmer or front office of Public Works, 260-6040 to arrange pick up.
6. No street may be blocked, unless there is a parallel street to handle the traffic.
7. Legible signs, no smaller than **2' x 3'**, must be used on the barricades.
8. Food tables, game tables, etc., must be placed in such a manner as to allow access for emergency vehicles.
9. No street that is a major thoroughfare may be considered.
10. Permits must be requested at least **ten (10)** days prior to the date of the Block Party.
11. Return completed petition to the Village of Glendale Heights, 300 Civic Center Plaza, Glendale Heights, IL 60139, Attn: Mayor's Office.
12. Approval of the application and map must be received from the Police and Fire Departments, before a Block Party permit is granted. Written authorization will be forwarded to the Block Party organizer/sponsor upon approval of the petition.
13. Block Parties may **NOT** be held by minors.
