

Village of Glendale Heights Parks and Recreation Department Facility Usage Guidelines and Application

Philosophy

The Glendale Heights Parks and Recreation facilities exist for the convenience and pride of the community. These facilities provide recreational and leisure services to the community. Parks and Recreation enhance the well being of the residents and provide a lifetime benefit. These facilities are open to all community residents.

To ensure that events in parks and public open spaces are compatible with our mission, they have to meet certain objectives, namely:

- To create a more livable, healthy community.
- To encourage people to use parks and public open spaces more.
- To instill and encourage community spirit and pride.
- To benefit the community economically.

Guidelines for Use

1. Any individual or group desiring use of a Parks and Recreation facility must apply by filling out an application. Upon receipt of the application, the department will assign designation to the group as defined herein.
2. Designated Village functions take preference over any other use of a particular facility.
3. A \$50.00 refundable security deposit must accompany all facility rental applications.
4. Sufficient adult supervision shall be provided by the individual/organization sponsoring the event.
5. Affiliate organizations shall submit annually current by-laws and financial records.
6. Individual/Organizations must pay the total usage fee as determined by the Department guidelines a minimum of seven days prior to the event starting date.
7. Individual/Organization is held financially responsible for any damage occurring to the facility.
8. No alcoholic beverages of any kind are permitted in a designated Park and Recreation facility.
9. No smoking is allowed in any Park and Recreation indoor facility.
10. Religious services, ceremonial services and political activities are prohibited in Park and Recreation facilities.
11. Any individual/organization that has three no-shows, without prior notification to the Parks and Recreation department at least 24 hours in advance, will have their space canceled.
12. Facility requests that include use of equipment not normally available at the site will be assessed an additional fee.
13. All individual/organization users shall hold the Village of Glendale Heights and its designees harmless from any action or suit by person or persons occasioned by the use of the Parks and Recreation facilities by said individual/organization.
14. The Director of Parks and Recreation must approve all applications.
15. All conduct will be in conformance with Village Code, 8-1-2 and 8-1-3.

This application, if approved, will serve as your permit for use of the facility described above and must be on the person responsible at the site.

DESIGNATION OF USER

Village Programming - Activities funded by the Village of Glendale Heights, specifically Parks and Recreation activities, Special Events Commission activities, and Founder’s Day Committee activities.

Affiliates - Large organizations (consisting of at least 100 members) closely associated with the Village and the Parks and Recreation Department and providing services which are not available through the Village and the Parks & Recreation Department, specifically, Community Football League, Glenside Baseball/Softball, School Districts 15, 16 & 87, and Glenside Cricket Academy.

Resident Service/Non-Service Organizations, Non-for-Profit Organizations and Individuals
 Category includes resident businesses, corporations, Junior Women’s Club, Lion’s Club, Glen Oaks Foundation, Village residents. Non-for-profit organizations are those that are tax exempt 501(c)(3) incorporated in the State of Illinois. Proof of status is required prior to approval.

Non Resident Organizations and Individuals - Any business, corporation, group or individual residing outside the boundaries of Glendale Heights.
