NEW BUSINESS:

 601 REGENCY DRIVE UNIT A – PUBLIC HEARING to consider an application for a Conditional Use permit for outdoor storage to permit the storage of forty-eight (48) 33.5 pound propane tanks on the north side of the building – Fergusion Fire & Fabrication, Inc.

Petitioner, Alan Atkinson of Virginia was sworn in before testifying before the commission. Mr. Atkinson is requesting approval for a conditional use for the storage The plan is to have forty-eight (48) 33.5 l. propane storage tanks located within a 19 foot long by 9 foot wide storage area. Ferguson uses propane forklifts as part of the daily operations. Empty propane tanks will be replaced with full tanks on site by Airgas, a liquid propane vendor, twice a week. The tanks will be stored

in cages within the loading dock apron of the building, which is more than 180 feet from the nearest property line and 350 feet away from Regency Drive . Vehicle impact guard rail protection will be installed around the storage area.

Plan Commissioner questioned the number of tanks, parking & refilling. Staff advised that there are no issues for the propane tanks located next door.

The meeting was open to the public. No one came forward.

The Commission reviewed the application and criteria for approving a Conditional Use as set forth in section 11-3C-5, B of the Zoning Ordinance with respect to traffic, environmental nuisance, neighborhood character, services and facilities and public safety. At this time, the commission did not find any concerns with the criteria for a conditional use.
