RIDE ALONG WAIVER

The undersigned does hereby request permission from the Police Department of the Village of Glendale Heights, Illinois to ride as a passenger and observer only, in an authorized Village of Glendale Heights Police Department motor vehicle.

The purpose of this request is to observe the activities and operations of a police officer during the course of his/her official duties.

I fully understand that I will be subject to any and all directions, supervisions and instructions given me by the police officer or officers in command of any vehicle in which I may be riding.

I further understand and have full knowledge of the basic nature of law enforcement work and fully realize the possibility that dangerous situations may arise which might result in my being physically harmed or injured, as well as fatally injured, including but not limited to motor vehicle accidents. I, nevertheless, freely and voluntarily assume these risks.

I hereby agree on behalf of myself, my heirs, assigns and personal representatives, to indemnify and save harmless the Village of Glendale Heights, its officers, agents and employees, against any and all claims, suits, actions or damages arising or resulting from personal injury, temporary, permanent or fatal, and any or all property damage or any loss of property I may sustain during the period of time I am acting in the capacity as an observer.

I hereby acknowledge that I am not receiving any compensation, salary or remuneration of any nature in my capacity as an observer.

I fully understand and agree that I shall not attain any right or benefit nor shall I be entitled to Illinois Workmen's Compensation Benefits as an employee of the Village of Glendale Heights.

Further, I shall not attain any rights or benefits under the Police and Fire Commission Act of the State of Illinois nor any similar ordinance of the Village of Glendale Heights, or any rights generally afforded sworn and non-sworn employees.
